For the implementation of a Blockchain Payment Infrastructure, cryptocurrency exchanges are a key pillar of this blueprint. We offer several options for consideration:

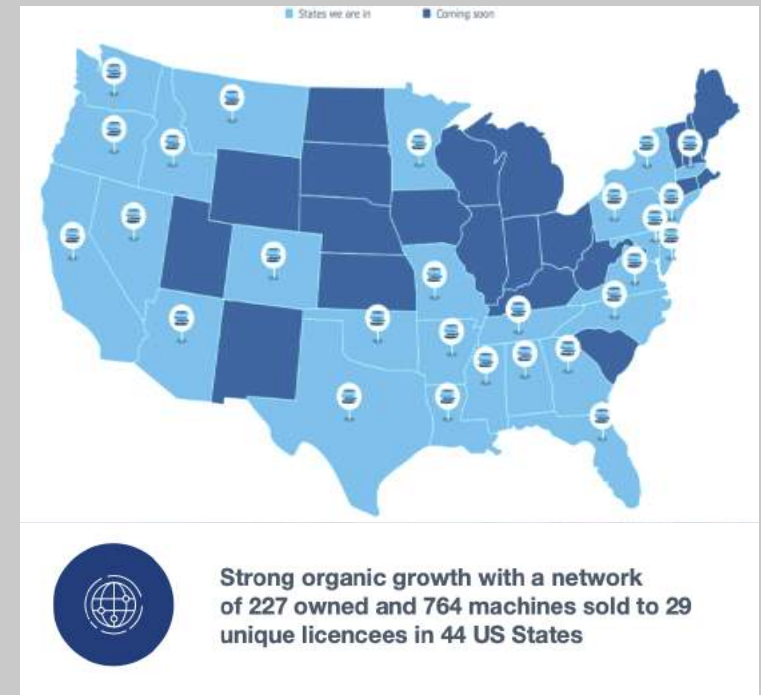

These exchanges are fully regulated and licensed according to the rules and regulations of the respective country. However, they will only operate under the new regulations of each country and jurisdiction.
- 2. Creation of a new crypto-exchange in a cooperative collaboration with an existing privately owned company or exchange.
- 3. Creation of a national crypto-exchange in cooperation with and under the supervision of the Central Bank and the national government.



2.1 Crypto- Automated Teller Machines:

To create a Blockchain Ecosystem, it is of utmost importance to set up payment networks to support it. ATMs are a vital component in this banking structure. We work with an operator from the United States, who is the the largest and most reputable global AMT operator. A cooperation with this company has the following benefits:

 - NYDFS (New York State Department of Financial Services) under the BitLicense



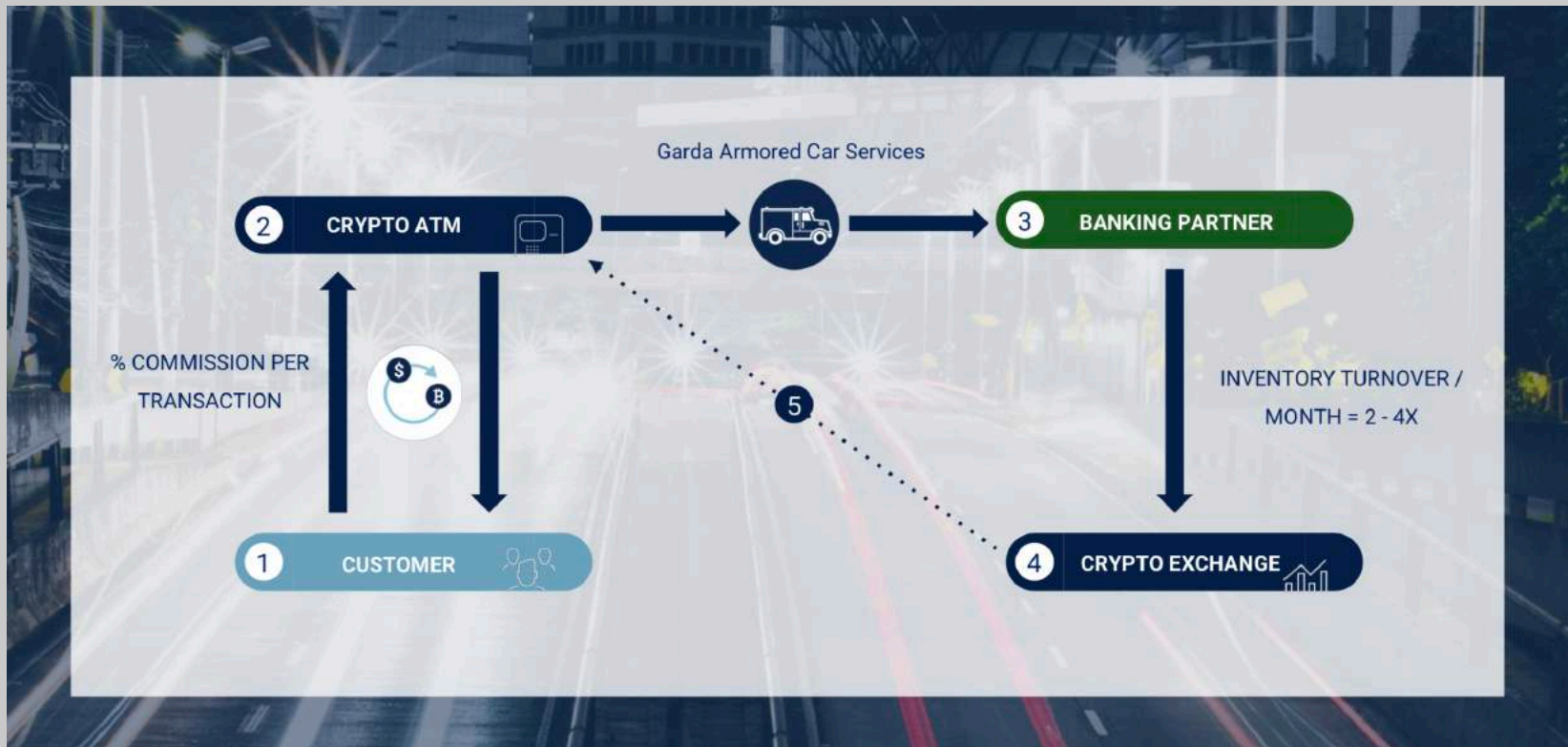


2.2 Crypto- Automated Teller Machines:

- **BitLicense:**
 - The BitLicense, which is issued by the NYDFS (New York State Department of Financial Services), regulates the safety and soundness of the digital currency business, including the company's strength of financial performance, executive leadership, cyber security, business continuity, customer service and most importantly Anti Money Laundering (AML) & Know Your Customer (KYC) compliance.
 - This **BitLicense** could be used as **blueprint** for any Central Bank to introduce new regulatory frameworks, which could speed up processes, accelerate governmental efficiencies, and lead to a faster financial return from the implementation of Blockchain strategies into the national banking system.
 - Phoenix Global Blockchain Technology and our ATM partners in the USA, are eager to cooperate and collaborate, assisting, advising and doing whatever is necessary to ensure a seamless and efficient implementation process that is secure, reliable, transparent and fully regulated (AML, KYC) under supervision of the Central Bank and the laws and regulations of any particular country.

Mobile crypto payment terminal

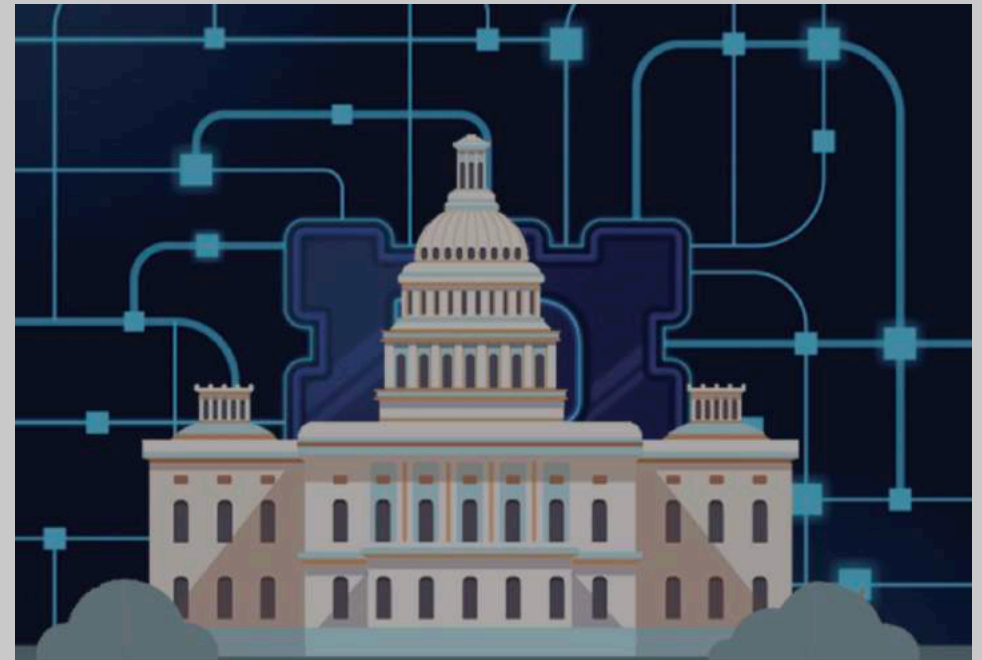
6. Tokenization and Token Economy:

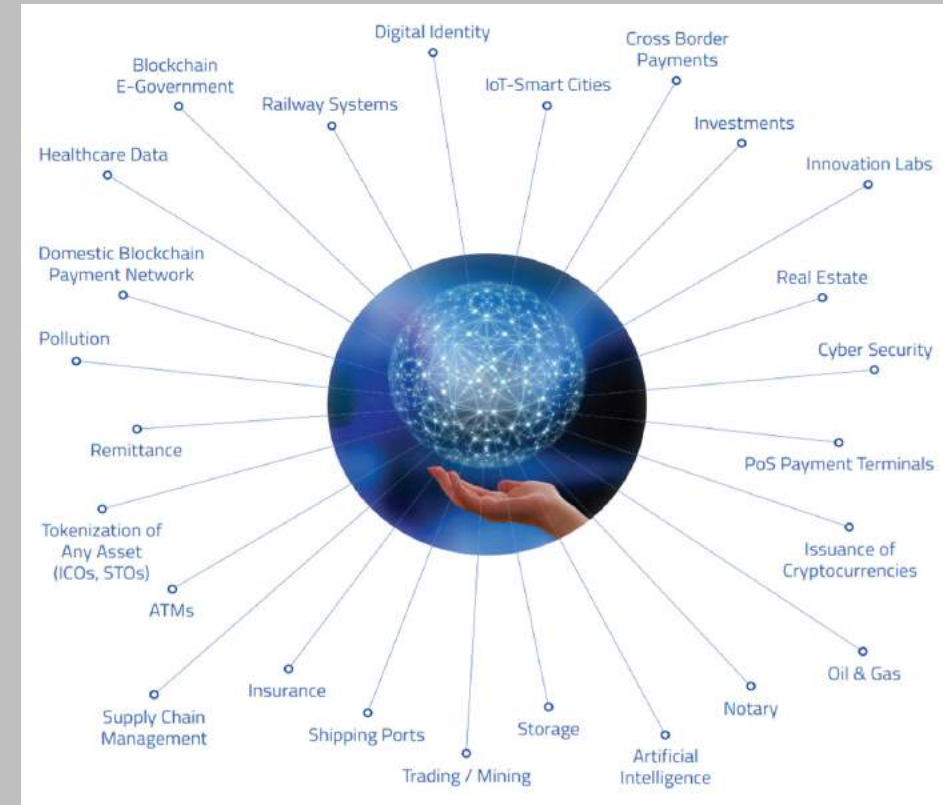
